

FACTS	WHAT DOES First Guaranty Mortgage Corporation dba goodmortgage.com DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal Law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect, and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> ▪ Social Security number and income ▪ Account balances and payment history ▪ Credit history and credit scores
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons First Guaranty Mortgage Corporation dba goodmortgage.com chooses to share; and whether you can limit this sharing.

What we do

How does First Guaranty Mortgage Corporation dba goodmortgage.com protect my personal information?	To protect personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does First Guaranty Mortgage Corporation dba goodmortgage.com collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> ▪ Give us your contact information or show your government-issued ID ▪ Provide employment information or provide your mortgage information ▪ Apply for a loan <p>We also collect your personal information from others, such as credit bureaus, affiliates, if any, or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> ▪ Sharing for affiliates' everyday business purposes – information about your creditworthiness ▪ Affiliates from using your information to market to you ▪ Sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.

Definitions

Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <p>Our affiliates include non-financial companies such as settlement agents and title companies</p>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial or nonfinancial companies.</p> <p><i>First Guaranty Mortgage Corporation dba goodmortgage.com does not share with nonaffiliates so they can market to you.</i></p>
Joint Marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <p><i>First Guaranty Mortgage Corporation dba goodmortgage.com does not jointly market.</i></p>

Other important Information

You may have other privacy protections under applicable state laws. To the extent the state laws apply, we will comply with them when we share information about you, and in some cases may be limited by you.

California Residents: We will not share your information with companies outside of First Guaranty Mortgage Corporation dba goodmortgage.com, except for **our** everyday business purposes, for marketing **our** products and services to you, or with your consent.

Nevada Residents: Pursuant to Nevada law, we are providing this notice, which applies to accounts with Nevada mailing addresses, to inform you that you may elect to be placed on our internal "do not call" list. Vermont Residents: We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures. Important Notice about Credit Reporting: We may report information about your account(s) to credit bureaus and/or consumer reporting agencies. Late payments, missed payments, or other defaults on your account(s) may be reflected in your credit report and/or consumer report.

Telephone Communications: All telephone communications with us or our authorized agents may be monitored or recorded.

Do Not Call Policy: This Privacy Notice constitutes First Guaranty Mortgage Corporation dba goodmortgage.com Do Not Call Policy under the Telephone Consumer Protection Act for all consumers. First Guaranty Mortgage Corporation dba goodmortgage.com maintains an internal Do Not Call preference list. Do Not Call requests will be honored within 30 days and will be effective for at least five years from the date of request. No telemarketing calls will be made to residential or cellular phone numbers that appear on the First Guaranty Mortgage Corporation dba goodmortgage.com Do Not Call list.
